



# Waiver of Liability, Assumption of Risk, and Indemnity Agreement

**Waiver:** In consideration of being permitted to participate in any way in the Club Sports Program, I, for myself, my heirs, personal representatives or assigns, **do hereby release, waive, discharge, and covenant not to sue** the Student Union of San José State University, Associated Students of San José State University, San José State University, the State of California, the Trustees of the California State Universities, and their officers, employees, volunteers and agents **from any and all claims** resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, participation in the Club Sports Program (*Initials* \_\_\_\_\_).

**Assumption of Risks:** Participation in the Club Sports Program carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains to 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions to 3) catastrophic injuries including paralysis and death. *Specific hazards or risks involved in the Racquetball Club include, but are not limited to the following:*

- Sprains, bruises, broken bones, & head injuries from racquets, people, or ball contact
- Bodily injuries from unexpected contact with walls or floors
- Eye damage that may not be eliminated by use of protective eyewear

*I understand that Racquetball requires a minimum level of fitness for safe participation and that the SJSU Club Sports Program recommends all participants have a physical examination to determine participation in Club Sports activities.*

**I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in the Club Sports Program. I hereby assert that my participation is voluntary and that I knowingly assume all such risks. (*Initials* \_\_\_\_\_).**

**Indemnification and Hold Harmless:** I also agree to INDEMNIFY AND HOLD the Student Union of San José State University, Associated Students of San José State University, San José State University, the State of California, the Trustees of the California State Universities, and their officers, employees, volunteers and agents HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in the Club Sport Program and to reimburse them for any such expenses incurred (*Initials* \_\_\_\_\_).

**Severability:** The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect (*Initials* \_\_\_\_\_).
